Re: Let Insurance Pensioners extend timely helping hand to People of Kerala at their hour of need

All India Insurance Pensioners' Association (AIIPA) calls upon all pensioners of the Insurance Industry to come to the aid of the LDF Government of Kerala, the God's Own Country, in tackling the 'unprecedented flood situation' now prevailing there.

The State of Kerala has witnessed continuous rains lashing in the past few days and according to reports, all rivers are in spate and sluice gates of 35 Dams have been opened.

With more rains forecast, Red Alert has been issued in fourteen Districts of the State, already more than 67 deaths have been reported with some still missing and about 1.5 lakhs people have been displaced and moved to Relief Camps and a Colony in Thiruvananthapuram where some of the LIC pensioners are residing has been flooded and they have been shifted to safer places. The flood waters have entered the ground floor of Kottayam Divisional Office and Branches at Pathanamthitta, Ranne, Thodupuzha, Chengannur and Pala under Kottayam Division have also been affected and could not be opened.

The Cochin Metro has become in-operational and Cochin Airport has been shut and one can very well imagine and understand the enormity and gravity of the flood situation.

The LDF Government of Kerala, led by its Chief Minister, Com. Pinarayi Vijayan, has risen up to the difficult task of extending relief to the affected people and has been marshalling all resources to provide succour and help to the scores of affected people, with the help of local comrades and Defence Personnel.

The efforts by the Kerala Government, while it is laudable and acknowledged by all, including the opposition parties, cannot be the sole source for relief operations. As a conscious part of the society, Insurance Pensioners owe their duty to the suffering populace of the State of Kerala.

AIIPA calls upon all pensioners to contribute liberally for the cause and that too, with the urgency required and immediately liberally remit their contribution to local Pensioners' Association.

Understanding the enormity of the situation, Pensioners' Associations in Kerala, have decided to collect a day's pension from all over the State and AIIPA conveys its sincere thanks to them.

All India Insurance Pensioners' Association (AIIPA), as an initial contribution, is sending Rs.1 Lakh to Chief Minister's Distress Relief Fund and all Pensioners' Associations shall consolidate the collections and directly remit(NEFT) to the Chief Minister's Distress Relief Fund.
