Re: Verification of Claims of CGIT Candidates by the Supreme Court
Appointed Committee

As informed earlier, vide AIIEA Circular No.20 of 2022 dated 9th May 2022, the Hon'ble Supreme Court of India had constituted a Committee for verification of the claims of the CGIT candidates who claim to have been employed for atleast 70 days in class IV posts over a period of three years or 85 days in class III posts over a period of two years. The Hon'ble Supreme Court also gave a direction that the verification would be confined to persons who were working between 20 May 1985 and 4 March 1991. Moreover, in carrying out the process of verification, the Committee shall not be confined to the certified list before the CGIT and shall consider the claims of all workers who were engaged between 20.05.1985 and 04.03.1991.

The Committee comprising of Hon'ble Justice Sri P.K.S.Baghel, Former Judge of Allahabad High Court and Sri Rajiv Sharma, Former District Judge and Member of UPHJS has now come up with a Public Notice inviting applications from the all the workers concerned to submit their claims **by 15.09.2022 latest by 4 PM**. The Public Notice issued by the Committee has already been sent to the zonal units today.

It is to be noted that the application is to be submitted strictly in accordance with **Format A** (as given in the Public Notice) along with all such documentary materials on which they rely upon for the purpose of the verification. The application form along with the documents has to be sent by **Registered Post or Speed Post to the** address given below:

We are sending the full list of the candidates whose cases had been taken up by AIEEA with the CGIT in 2018.

We would request the Zonal / Divisional Units to contact the candidates pertaining to their jurisdiction (our list contains the names of the Division/ Branch where the candidate claims to have worked), and help them in completing the application as per Format A and sending the same to the office of the Committee as noted above. **Please also take care to ensure that the information being furnished now tallies with the ones given earlier in 2018 and are supported by relevant documentary evidence.**

We request the zonal units to compile the consolidated list of candidates submitting their applications and send a copy of the same to AIEEA for our records. Separate list may kindly be prepared for such candidates whose names do not figure in our list but they claim to have worked between 20.05.1985 and 04.03.1991.

We request our units to take up this work on an urgent basis so that there is no last minute hurry.
